Proposed Work and Purpose: The applicant repaired roof membrane and sheeting and replaced drains, vents, and

insulation. Interior ceiling tiles were replaced. Exhaust fan and HVAC cooling tower were repaired. Concrete walkway in garden was repaired. Elevator eye sensor, fire alarm pull station, molecular imaging camera, and dumpster lids were repaired. Painting, caulking, resealing, and re-screening frames and joints was preformed throughout the facility.

Work returned facility to the pre-disaster condition.

Project Alternatives: The alternative that has been considered is the no action alternative. With the no action

alternative, negative impacts on residents and the community may be experienced. Alternate locations were not considered as there would not be areas outside of the floodplain that would serve the community needs and relocation of the facility would

not be practicable.
